

# Mitchell Award2025

**Nomination Process** 

### **Scheme Criteria:**

The Adelaide Health Foundation (AHF) is committed to supporting nurses in Tallaght University Hospital (TUH) in respect of both their professional development and the development of nursing practice in the hospital.

The objective of the Mitchell Award is to recognise that the role of nursing is at the heart of Patient Care. It will be awarded to TUH Staff Nurse(s) (including CNM1, CNM2, Clinical Nurse Specialist, ANP & cANP) who are deemed to have displayed commitment and excellence in compassionate care for both the patient and their family.

It highlights the importance of listening, empathy and respect in nursing care, keeping the patient and their families at the heart of nursing. In respect of the AHF's Core Values, the award is for nurses who have demonstrated their recognition of equal access to quality healthcare for all and shows respect of the patient's dignity, and their right to self-determination over their healthcare.

Up to four nurses may be selected per year for the Mitchell Award which is valued at €500 each.

Closing date for receipt of applications is 12 noon, 12th December 2025.

Late applications cannot be accepted.

- 1. All Application forms must be fully completed.
- 2. Nominations form must include at least one direct patient care example or family interaction.
- 3. Closing date for receipt of applications is 12 noon, 12th December 2025. Late applications cannot be accepted.
- 4. Nominated Nurses are in permanent employment with TUH at the time of granting the Award.
- 5. Each nomination must be approved by the nurse's line manager.
- 6. A minimum of two Staff grade nurses will be selected to receive this award.
- 7. The decision of the Adelaide Health Foundation is final.
